All India Institute of Medical Sciences (AIIMS), Gorakhpur, an apex healthcare institute established by an Act of Parliament of India under aegis of Ministry of Health & Family Welfare, Government of India, invites Online bids in two bid system for Tender for Supply of books for central library at the Institute. You are requested to quote your best offer along with the complete details of specifications, terms & conditions.

Chapter I- Instruction to bidders

- 1. Bids shall be submitted online only at CPPP website: https://eprocure.gov.in/eprocure/app.
- 2.The complete bidding process in online. Bidders should be in possession of valid digital Signature Certificate (DSC) of class II or III for online submission of bids. Prior to bidding DSC need to be registered on the website mentioned above. In case the supplier requires any elucidation regarding the tender documents, they are requested to contact to AIIMS Gorakhpur through e-mail: procurement@aiimsGorakhpur.edu.inon or before end date of clarification as per critical date sheet.
- 3. Tenderer/Contractor/Bidders are advised to follow the instructions provided in the 'Instructions to the Contractors/Tenderer/Bidders for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at https://eprocure.gov.in/eprocure/app.
- 4. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 5 Bid Validity- 90 Days from the date of opening of Bid.
- 6. EARNEST MONEY DEPOSIT [EMD]:-

Earnest money (i.e.₹ 72,000/-) by means of a Bank Demand Draft a scanned copy to be enclosed. It is also clarified that the bids submitted without earnest money will be summarily rejected. The DD may be prepared in the name of "The Director, AIIMS Gorakhpur". The EMD cost must reach at Central Library, AIIMS Gorakhpur-273008 before opening of tender.

- i) No request for transfer of any pervious deposit of earnest money or security deposit or payment of any pending bill held by the AIIMS Gorakhpur in respect of any previous supply will be entertained. Tenderer shall not be permitted to withdraw his bid or modify the terms and conditions thereof. In case the tenderer fail to observe and comply with stipulations made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited.
- ii) Tenders without Earnest Money or Tender cost will be summarily rejected.
- iii) No claim shall lie against the AIIMS Gorakhpur in respect of erosion in the value or interest on the amount of EMD.
- iv) If MSE firm is registered with following agencies for tendered item then they are exempted for submission of EMD.
 - (i) District Industries Centers.
 - (ii) Khadi & Village Industries commission.
 - (iii) Khadi & Village Industries Board.
 - (iv) Coir Board.
 - (v)) National Small Industries Corporation (NSIC).
 - (vi) Directorate of Handicraft & Handlooms.
 - (vii) Any other body specified by Ministry of MSME (Ministry of Micro, Small & Medium Enterprises).

If MSE's who are interested in availing these benefits will have to attach with their offer the proof of their beings MSE"s registered with any of the above mentioned agencies.

v) The earnest money will be returned/refund to the unsuccessful tenderers after the tender is decided.

EMD should remain valid for a period of 45 days beyond the final bid validity period. When the tenderer agrees to extend the validity of bid, he shall also extend the validity of EMD suitably.

7. Purchase Preference to Local Suppliers

In pursuance of Government of India Order No. P-45021/2/2017-B.E.-II dated 16th September 2020 (as amended from time to time) and F.No. Z.28018/67/2017-EPW dated 12th June 2018 purchase preference shall be given to local suppliers in all procurements undertaken in the manner specified hereunder and the procurement shall be made as per terms and conditions contained in the said order.

- (i) Minimum local content: The minimum local content shall as per Government of India Order No. P-45021/2/2017-B.E.-II dated 16th September 2020 (as amended from time to time) and F.No. Z.28018/67/2017-EPW dated 12/06/2018, till the Nodal Ministry prescribes a higher or lower percentage.
- (ii) Margin of Purchase Preference: The margin of purchase preference shall be 20%. The Local supplier whose quoted price falls in the margin of purchase preference desirous of claiming benefit of the Order No. P-45021/2/2017-B.E.-II dated 16th September 2020 shall submit an undertaking within 7 days of opening of financial bid, that he would be ready to supply the product at L1 price. In case of non-receipt of the same, he would not be given purchase preference.
- (ii) The bidders are required to submit the following annexure in compliance of public procumbent (Preference to Make in India) order, 2017: Affidavit of self-certification regarding local content (to be provided on Rs. 100/- stamp paper as per Chapter-IX).
- (iv) All other terms & conditions will be as per the Department of Industrial Policy and Promotion (DIPP) order No. P-45021/2/2017-B.E.-II dated 16th September 2020 (as amended from time to time).
- 8. Land Border Sharing as per Certificate regarding compliance Rule-144 (xi), any bidder from such countries sharing a land border with India will be eligible to bid in any procurement whether of goods, services (including consultancy services and non-consultancy services) or works (including turnkey projects) only if the bidder is registered with the Competent Authority. Bidders to submit self declaration on their letter head as per Chapter-X.

Chapter-II- Conditions of Contract

General Terms and Conditions

Subject: - Notice inviting bids for Tender of Books for central library at All India Institute of Medical Sciences, Gorakhpur

1. Parties:

The parties to the contract are the contractor (the tenderer to whom the work have been awarded) and the AIIMS through Administrative Officer, All India Institute of Medical Sciences, Gorakhpur for and on behalf of the Director, AIIMS, Gorakhpur.

- 2. Proposal for supply of books may be submitted in the prescribed format and all columns may be filled up. Incomplete proposal sand tenders received after due date shall not been entertained. The Institute shall not be responsible for any postal delay and delay in receipt of the offer. Any bids received by the Institute which does not fulfill the desired terms and conditions shall be rejected out rightly and no communication in this regard shall be sent. Delayed / Late Bids will not be accepted, at any circumstances.
- 3. Quotations qualified by such vague and indefinite expression such as "Subject to prior confirmation", Subject to immediate acceptance" etc. will be treated as vague offer sand rejected accordingly. Any conditional tender shall be rejected summarily.
- 4. The Publisher's / principals offering for the Supply of books may furnish the name and address of their

local authorized distributor / dealer, so that the copies of orders can be endorsed to them for expeditious supply. In such cases where local dealers/stockiest has been nominated by the principal, the bills raised by them against our purchase order will be accepted.

- 5. Any addition and deletion of authorized dealership / distributorship shall be intimated to the undersigned immediately on authorization of a new party.
- 6. At any time prior to date of submission of tender, Tender Inviting Authority may, for any reason or decision, modify the terms & conditions of the tender document by a corrigendum displayed on the website of AIIMS Gorakhpur (http://www.aiimsgorakhpur.edu.in). In order to provide reasonable time to take the amendment into account in preparing their bid, Tender Inviting Authority may or may not, at his discretion, extend the date and time for submission of tenders.
- 7. The bidders are required to mention tax rate applicable on each category otherwise, rates will be treated as inclusive of all taxes.
- 8. In case of discrepancy between unit price & total price, the unit price shall prevail.
- 9. The rate quoted by each firm in tenders be given both in words and figures failing which the same is liable to be rejected. Tenderer is at liberty to be present or to authorize a representative to be present at the time of opening of the tenders.
- 10. In case of supply of books made through valid authorized dealer, their name & mail address may be declared / indicated in the tender.
- 11. Authorization certificate in respect of foreign firms duly self-attested and showing validity period may be submitted.

12. DOCUMENTS COMPRISING THE BID:

The bids prepared by the bidder shall comprise of (1) Technical Bid and (2) Financial Bid:

Technical Bid:- To qualify in the Technical Bid the firm should have the minimum eligibility criteria as under and the firm in this regard must submit the following documents in support of their eligibility criteria:-

- (a) Valid registration certificate of the firm of the Govt./State Govt.
- (b) Duly filled format of Technical Bid as per Chapter –IV.
- (c) Copy of constitution or legal status of the bidder manufacturer / Sole proprietorship / firm / agency etc.
- (d) Price list of the items from the Principal.
- (e) Local Authorized Dealer must attach authorization Certificate from the principal.
- (f) PAN number with document
- (g) GST No. with document
- (h) The bidder shall be a publisher/ Distributers /Agents (Certificate of authorization must be attached).
- (i) Financial Status: The average annual turnover from similar jobs, of the quoting firm should not be less than 20 Lakh in the last three financial years (2017-18, 2018-19 & 2019-20). Copies of profit & loss account and balance sheets duly authenticate by a Chartered Accountant for the last three years should be enclosed.
- (j) Copy of Income Tax Return Acknowledgement for last Three years.
- (k) Copy of PAN Card / Service Tax Registration.
- (l) Copy of GST registration certificate.
- (m) Registration with Excise Department, Govt. of India. The industries situated in excise free zones will be exempted from registration provided they produce the copy of appropriate notification.
- (n) Details of clients where similar services are presently provided by the tenderer separately for

govt. and private clients.

- (o) The bidder must have experience of execution of similar work in atleast 3 Govt. Medical College for last three years. Necessary supporting documents like work orders, work completion certificate, payment certificate etc. for last three years from 03 institutions to this effect must be submitted along with the offer.
- (p) The concerned firm/company whose product has been declared as of spurious or plagiarized quality and any criminal cases is filled and is pending in any court shall not bee ligible to participate in the bidding process. Convicted firms /company shall also not be eligible to participate in the bid. Similarly, blacklisted / banned / debarred firms / company by any central / state govt. or its organization or autonomous bodies or central drug procurement agency is not eligible to participate in the bid.
- (q) Brochure, original book catalogue with detailed specification of the product offered, if relevant. Financial Bid: The financial bid shall contain:
- (a) (a) Price bid in the form of BOQ_XXXX .xls

13. Signing of Tender:

Individual signing the tender or other documents connected with contract must specify whether he sign as:

- (a) A sole proprietor of the concern or constituted attorney of such sole proprietor;
- (b) A partner of the firm, if it is a partnership firm in which case he must have authority to execute the contracts on behalf of the firm and to refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership agreement or by a power of attorney duly executed by the partners of the firm.
- (c) Director or a principal officer duly authorized by the Board of Directors of the Company, if it is a company.
- 14. A person signing the tender form or any document forming part of the tender on behalf of another person should have an authority to bind such other person and if, on enquiry it appears that the person so signing had no authority to do so, AIIMS, Gorakhpur may without prejudice, cancel the contract and hold the signatory liable for all costs, consequences and damages under the civil and criminal remedies available.
- 15. The tenderer should sign and affix his firm's stamp at each page of the tender, all its annexure as the acceptance of the offer made by tenderer will be deemed as a contract, and no separate formal contract will be drawn. NO PAGE SHOULD BE REMOVED/ DETACHED FROM THIS NOTICE INVITING TENDER.

16. BID PRICES:

- (a) It should be submitted in form given in Chapter VII. The price quoted will be exclusive of taxes and inclusive of all applicable charges (i.e. packing, forwarding, postage and transportation) at F.O.R. AIIMS, Gorakhpur and shall be fixed and final. Taxes, as applicable will be extra, which will be separately quoted in the bid, at the time of payment Income Tax or any other Tax payable shall be deducted at source.
- (b) The offer shall be firm and in Indian Rupees only. No foreign exchange will be made available by the Institute.
- (c) The rate quoted by the bidder shall remain fixed during the entire period of contract and shall not be subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.

24. TECHNICAL EVALUATION:

(a) Detailed technical evaluation shall be carried out by Purchase Committee pursuant to conditions in the tender document to determine the substantial responsiveness of each tender. For this clause, the substantially responsive bid is one that conforms to all the eligibility and terms and condition of the tender without any

material deviation. The Institute's determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. The Institute shall evaluate the technical bids also to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are in order.

- (b) The technical evaluation committee may call the responsive bidders for discussion or presentation to facilitate and assess their understanding of the scope of work and its execution. However, the committee shall have sole discretion to call for discussion / presentation.
- (c) Financial bids of only those bidders who qualify the technical criteria will be opened provided all other requirements are fulfilled.
- (d) AIIMS Gorakhpur shall have right to accept or reject any or all tenders without assigning any reasons thereof.

25. FINANCIAL EVALUATION:

- (a) The financial bid shall be opened of only those bidders who are found to be technically eligible. The financial bids shall be opened in presence of representatives of technically eligible bidders, who may like to be present. The Institute shall inform the date, place and time for opening of financial bid.
- (b) Arithmetical errors shall be rectified on the following basis. If there is a discrepancy between the unit price and total price that is, the unit price shall prevail and the total price shall be corrected by the Institute. If there is a discrepancy between words and figures, amount in words shall be considered as valid. If the Supplier does not accept the correction of the errors, his bid shall be rejected.
- (c) The AIIMS Gorakhpur does not bind itself to accept the lowest bid or any bid and reserves the right of accepting the whole or any part of the bid or portion of the job offered; and the bidder shall provide the same at the rates quoted. AIIMS Gorakhpur, reserves the right to reject any or all offers received in response to tender or cancel or withdraw the tender notice without assigning any reason, whatsoever.

26. AWARD OF CONTRACT: PLACEMENT OF ORDER:

The Institute shall consider placement of orders for jobs on those bidders whose offers have been found technical, commercially and financially acceptable. The Institute reserves the right to counter offer price(s) against price(s) quoted by any bidder. L1 will be decided on individual item basis.

27. Opening of Tender:

The tenderer is at liberty either himself or authorize not more than one representative to be present at the opening of the tender. There preventative at tending the opening of the tender on behalf of the tender should bring with him a letter of authority from the tenderer and proof of identification.

28. Right of acceptance:

The AIIMS, Gorakhpur reserve the right to accepting the whole or any part or portion of the bid; and the bidder shall provide the same at the rates quoted. The AIIMS Gorakhpur reserve the right to reject any or all tenders / quotations or all offers received in response to the tender or cancel or withdraw the tender notice without as signing any reason there of and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall been entertained.

29. Delivery:

The supplier shall make delivery of books within 90 days from date of purchase order.

30. Liquidated Damages

Supply of material will have to be completed within specified period in the purchased order. The liquidated damages charges @ 0.5% per week of the value of that part of the goods that, as a consequence of the delay, shall be imposed if supply made after expiry of delivery period subject to maximum 10% of the total value of goods/contract value. Quantum of liquidated damages assessed and levied by the purchaser shall be final and not challengeable by the supplier.

31. Risk Purchase

If successful tenderer fails to supply books within the stipulated delivery date or books supplied other than specification specified in our NIT, AIIMS Gorakhpur reserves the right procure same or equivalent

books from alternative sources at the vendor's risk, responsibility and cost. Any extra cost incurred in the procurement of the books from alternative source will be recovered from the Security Deposit / Bank Guarantee and Pending Bills and if the value of the materials under risk purchase exceeds, the amount of Security Deposit and / or Bank Guarantee and Pending Bills, the same may be recovered if necessary by due legal process.

32. The Payment clause: 100% payment after supply and acceptance by the user subject to following. The bill in triplicate may be sent to this office for settlement after satisfactorily delivery of the material. The bill should have full particulars of the items(s).

No payment shall be made in advance nor shall the loan from any bank or financial institutions be recommended on the basis of the order of award of work.

The contractor shall submit the bill only after supply of the books to the satisfaction of the AIIMS Gorakhpur, on receipt of a pre-receipted bill invoice from the Contractor the case of issuing sanction and passing of bill for payment will be initiated. No payment will be made for books rejected

33. Performance Security:

The successful tenderer will be required to furnish a Performance Security Deposit equivalent to 5% of the value of the contract to be deposited after receiving of award of contract in the form of Fixed Deposit Receipt or Bank Guarantee from any Nationalized Bank duly pledged in the name of the "The Executive Director, AIIMS Gorakhpur" which shall be kept valid for a period of 60 days beyond completion of all the contractual obligations. In the event of non-deposition of the same the earnest money will be forfeited. The security deposit can be forfeited by order of this Institute in the event of any breach or negligence or non-observance of any condition of contract or forum satisfactory performance or non- observance of any condition of the contract. Performance Security will be discharged after completion of contractor's performance obligations under the contract

No interest on security deposit and earnest money deposit shall be paid by the Institute to the tenderer.

34. The technically qualified Bidder who submits the lowest rate in financial bid shall be declared as successful bidder (L1) and communication to that effect shall be made subject to approval and as decided by the competent Authority.

35. Breach of Terms and Conditions:

In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to cancel the work order/job without assigning any reason there of and nothing will be payable by AIIMS, Gorakhpur in that event the security deposit shall also stands forfeited.

36. Subletting of Work:

The firm shall not assign or sublet the work/job or any part of it to any other person or party without having first obtained permission in writing of AIIMS, Gorakhpur, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one tenderer.

37. Arbitration:

If any conflict or difference arises concerning this agreement, its interpretation on payment to the made there-under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute for decision by an Arbitral Tribunal containing Sole Arbitrator to be appointed by the Director, AIIMS Gorakhpur. Such requests shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing, unwilling or becoming in capable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1990 and the rule framed there under and in force shall be applicable to such proceedings.

38. Legal Jurisdiction:

The agreement shall be deemed to have been concluded in Gorakhpur, Uttar Pradesh and all obligations here under shall be deemed to be located at Gorakhpur, Uttar Pradesh and Court within Gorakhpur, Uttar Pradesh will have Jurisdiction to the exclusion of other courts

Chapter - III Other terms & conditions of the Contract

- 1. The successful firm will be required to do the work / job for the period of contract from the date of award the contract. AIIMS, Gorakhpur shall, however, reserve the right to terminate the contract at any time without assigning any reason.
- 2. The items will have to be supplied at AIIMS, Gorakhpur. No transportation/ cartage charges will be provided for the same.
- 3. The firm may supply the required books as per unit price mentioned in the pricelist.
- 4. The books should be securely packed to avoid damages etc. in transit.
- 5. All India Institute of Medical Sciences (AIIMS), Gorakhpur shall be the sole authority to cancel or amend the order, as per requirement, and also to place order for supply of item beyond office hours/holidays/place of supply for which, no additional payment shall be made.
- 6. In case a proposal is accepted the supplier/principal will have to sign an agreement deed with us on a non-judicial stamp of appropriate value while entering into supply of books .
- 7. The firm should have availability of a responsible person on call on all working days between 09:00 Hrs to 18.00 Hrs.
- 8. The books shall be delivered at the AIIMS, Gorakhpur should be the latest edition of it available and if due for re edition need to be mentioned at time of delivery.
- 9. Order shall be issued for tentative annual requirement on actual need basis. Bills in triplicate for the books supplied by the selected firm(s), should be raised for payment. Payment shall be released after it is ensured that the quantity and quality of books supplied are to the entire satisfaction of this office and accepted. If any book is found to be defective, or misprinted or missing pages, the same shall be replaced immediately, for which no extra payment shall be made by AIIMS, Gorakhpur.
- 10. The selected tendering Firm/Agency/Company shall also provide the name and mobile number of a key person, who can be contacted at any time, even beyond the office hours on holidays. The person should be capable of taking orders and making arrangement for supply of the desired books even on short notice to AIIMS, Gorakhpur.
- 11. In case the print of books supplied are not in conformity with the standard given in tender or the supplies are found defective at any stage the books shall immediately will be taken back by the supplier and will be replaced with the tender quality books, without any delay. The Purchase Committee reserves all right to reject the books if the same are not found in accordance with the required description / specifications and liquidates damages shall be charged.
- 12. Each page of the Tender Notice to be signed and stamped by the bidder in token of having accepted the same.
- 13. Discount: The Discount which will be offered by the publisher/authorized distributors on the

publisher's price list for the contract year may be mentioned. Firms must offer a flat discount rate on all books instead of separate discount on different books. Discount rates offered by the firms shall not be linked with the quantum of the purchase order.

- 14. GST: The rate of GST should be mentioned clearly.
- 15. Authorization Letter: Authorization letter from the publisher for the current financial year should be submitted along-with quotation, failing which quotations will not be considered.
- 16. The AIIMS, Gorakhpur reserves the right to place an order for supply of any book mentioned in the Financial Bid or otherwise, to any other firm(s) in emergency/unavoidable situation.
- 17. The all Books should be good condition and latest edition and original copy published by the publisher (not pirated).
- 18. The Supplier shall supply all the ordered books within 90 days from the date as specified in the purchase order. If the supply is not received within the stipulated time, the Director, AIIMS, Gorakhpur reserves the right to cancel either the entire order or part thereof without any further notice/reminder. In case, the supplier needs some more time for supply, he/she should seek in writing on sound grounds, further time from the concerned officer at least four days before supply date expires.
- 19. All Books/Annual Reviews/ Monographs shall be supplied with an authentic price proof
- 20. The Supplier shall append the declaration on the bill that Only the latest editions of the books etc. have been supplied
- 21. The actual prices of Publications have been charged without any handling/postage charges.
- 22. These are not remaindered titles/ damaged books with missing pages.
- 23. The Indian/Low priced editions of these publications (if foreign) are not available in India.
- 24. Damaged books, books with missing pages shall have to accept back by the supplier even after they have been stamped for accessioning.
- 25. Any Supplier found to have cheated by supplying old and remaindered books and defaulted in supplying books even on extended time limit without reasonable grounds, will be liable for blacklisting besides imposition of penalty that may deem fit.
- 26. In case of cheating by charging more than actual Publisher's Price, the Firm can be punished by blacklisting/forfeiting the Performance Security deposit or both.
- 27. All books carry a discount as per the agreed terms.
- 28. If a book is ordered from abroad, we should be informed accordingly before sourcing it.
- 29. The latest paperback editions should always be supplied unless otherwise mentioned. Indian reprints/editions, if available should be supplied. Librarian of AIIMS, Gorakhpur should be consulted beforehand if vendors intend to supply hardback editions, if the ordered paperback edition is not available.
- 30. This order would be treated as cancelled, if the books are not supplied or no report as to availability or otherwise is received within this period.
- 31. Librarian should certify on the invoice that the prices quoted there in are the publisher's current prices. And, enclose the stamped price proof along with the invoice.

32. Payment will be made within 45 days from date of receipt of the invoice.

Disclaimer:

The near relatives of employees of AIIMS, Gorakhpur are prohibited from participation in this tender. The near relative for this purpose are defined as:

- (a) Members of a Hindu undivided Family.
- (b) Their spouses
- (c) The one related to the other in the manner as father, son(s), Son's wife (daughter-in-law), daughter(s) and daughter's husband (sons-in-law) brother (s) and brother's wife, sister(s) and

Special Conditions:

- 1. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.
- 2. More information useful for submitting online bids on the CPP Portal may be obtained at: https://eprocure.gov.in/eprocure/app.

REGISTRATION

- 1. Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrolment" on the CPP Portal which is free of charge.
- 2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
