Instruction to candidates

AIIMS Gorakhpur would conduct the MBBS admission for the year 2023 through the NEET UG examination following the guidelines of the online counselling being conducted by the Medical Counselling Committee (MCC)(<https://mcc.nic.in/UGCounselling/>).

The candidates are advised to go through the NEET UG 2023 prospectus in the MCC website and the 'NOTICE REGARDING MBBS 2023 ADMISSION (NEET UG Counselling)' available below (and in the Institute website) carefully.

No candidates would be allowed for reporting without original certificates and any other requirements as notified by the Medical Counselling Committee.

The candidates are also advised to bring **one set of self- attested Xerox copies of all original certificates/ documents.**

A. NUMBER OF SEATS & RESERVATION:

The 125 (One hundred and twenty-five) seats for Indian Nationals are available for admission to MBBS course at AIIMS, Gorakhpur. The policy of reservation of Government of India is applied at AIIMS. The reservation roster for the AIIMS seats shall be applied by the MCC of DGHS, MoHFW.

B. CRITERIA FOR OTHER BACKWARD CLASSES (NON-CREAMY LAYER) [OBC]:

Reservation for OBC (Non-Creamy Layer) the certificate must be valid for admission in Central Government Institute shall be according to the rules of the Government of India. Applicants are required to ensure that he/she does not belong to the persons/sections (Creamy Layer) mentioned

C. CRITERIA FOR SCHEDULED CASTE / SCHEDULED TRIBE (SC /ST):

Reservation for SC/ST candidates will be according to the rules of Government of India. Applicants will be required to produce the necessary certificate in the format provided (Annexure 2). During counselling the certificate as prescribed in M.H.A., O.M., No. 42/21/49-N.G.S. dated the 28.1.1952, as revised in Dept. of Per-& A.R. letter No. 36012/6/76-Est. (S. CT), dated the 29.10.1977, to be produced by candidate belonging to a Scheduled Caste or a Scheduled Tribe in support of his/her claim.

D. CRITERIA FOR PERSONS WITH BENCHMARK DISABILITY (PWBD):

In accordance with the provisions of the Rights of Persons with Disabilities Act, 2016, 5% seats of the annual sanctioned intake capacity shall be filled up by candidates with benchmark disabilities, based on the merit list of Entrance Examination. **The candidate must possess a valid disability certificate generated online by the MCC portal from any of the MCC designated center.** All PwBD candidates shall be evaluated by a Medical Board of the Institute to determine eligibility.

E. CRITERIA FOR ECONOMICALY WEAKER SECTION (EWS):

Reservation for EWS, the certificate must be valid for admission in Central Government Institutes shall be according to the rules of the Government of India. Applicants will be required to produce the necessary certificate in the format provided at the end of the prospectus in support of his/her claim (Annexure 3).

The EWS certificates issued from 1st April, 2022 (inclusive) and start of reporting of Round-1 of MBBS counselling schedule as notified by (Medical Counselling Committee for MBBS admission) will be considered valid.
