BD SurePath™ Direct to Slide Kit Specimen Processing Procedure



After the sample is collected using a Rovers® Cervex-Brush® or equivalent sampling device, rinse the brush head directly into the fluid, remove from the handle and drop into the larger opening of a BD SurePath™ Collection Vial. Tightly cap the vial, label, send to the laboratory, and accession.



Place the labeled BD PreCoat™ Slide(s) into the BD SurePath™ Direct to Slide Kit Slide Holder. Attach a BD Settling Chamber.



Pipet 1 mL of BD Density Reagent into the BD Settling Chamber.



Vortex the BD SurePath Collection Vial for 15 seconds.

Note: Sufficient volume is available in the BD SurePath Collection Vial to allow removal of up to 0.5 mL of homogenous mixture of cells and fluid for ancillary testing, while still allowing sufficient volume for Pap testing. The aliquoting may be performed after this vortexing step in the BD SurePath Direct to Slide process.



Slowly pipet 2 mL of sample into the BD Settling Chamber.

Note: Hold the tip of the pipet onto the edge of the BD Settling Chamber. Be careful not to disrupt the BD Density Reagent surface.



Place the BD SurePath Direct to Slide Kit Slide Holder with sample into a compatible centrifuge and spin at 200 g for 2 minutes.



Remove the BD SurePath Direct to Slide Kit Slide Holder from the centrifuge. Decant, and wash the sample by pipetting 1 mL of BD Alcohol Blend Rinse or equivalent.

Note: Hold the tip of the pipet onto the edge of the BD Settling Chamber. Be careful not to dislodge the cells from the surface of the slide.

Decant by inversion. Repeat X 1.



Invert the BD SurePath Direct to Slide Kit Slide Holder for 1 minute. Remove the BD Settling Chamber. Place the slide(s) in a BD Alcohol Blend Rinse or equivalent.
