Instruction to candidates

AIIMS Gorakhpur would conduct the MBBS admission for the year 2025 through the NEET UG examination following the guidelines of the online counselling being conducted by the Medical Counselling Committee (MCC) (<https://mcc.nic.in/UGCounselling/>).

The candidates are advised to go through the **NEET UG 2025 prospectus** in the **MCC website** and the '**NOTICE REGARDING MBBS 2025 ADMISSION (NEET UG Counselling)**' below and in the Institute website carefully.

- 1. No candidates would be allowed for reporting without original certificates and any other requirements as notified by the Medical Counselling Committee.**
- 2. The candidates are also advised to bring one set of self- attested Xerox copies of all original certificates/ documents and 5 passport size pics.**

A. NUMBER OF SEATS & RESERVATION:

The 125 (One hundred and twenty-five) seats for Indian Nationals are available for admission to MBBS course at AIIMS, Gorakhpur. The reservation roster for the AIIMS seats was displayed at MCC website.

B. CRITERIA FOR OTHER BACKWARD CLASSES (NON-CREAMY LAYER) [OBC]:

Reservation for OBC (Non-Creamy Layer): the certificate must be valid for admission in Central Government Institute shall be according to the rules of the Government of India. Applicants are required to ensure that he/she does not belong to the persons/sections (Creamy Layer) mentioned

C. CRITERIA FOR SCHEDULED CASTE / SCHEDULED TRIBE (SC/ST):

Reservation for SC/ST candidates will be according to the rules of Government of India. Applicants will be required to produce the necessary certificate in the format provided (Attached below). During counselling the certificate as prescribed in M.H.A., O.M., No. 42/21/49- N.G.S. dated the 28.1.1952, as revised in Dept. of Per-& A.R. letter No. 36012/6/76-Est. (S. CT), dated the 29.10.1977, to be produced by candidate belonging to a Scheduled Caste or a Scheduled Tribe in support of his/her claim.

D. CRITERIA FOR PERSONS WITH BENCHMARK DISABILITY (PWBD):

In accordance with the provisions of the Rights of Persons with Disabilities Act, 2016, 5% seats of the annual sanctioned intake capacity shall be filled up by candidates with benchmark disabilities, based on the merit list of Entrance Examination 2025. For this purpose, the specified disability contained in the Scheduled to the right of Persons with Disability Act, 2016 is attached below.

The candidate must possess a valid disability certificate generated online by the MCC portal from any of the MCC designated center. All PwBD candidates shall be evaluated by a Medical Board of the Institute to determine eligibility.
