<u>GB-06/05</u> Confirmation of the Action Taken Report on the Minutes of Extraordinary Meeting of the Governing Body, AIIMS Gorakhpur held on 29.10.2024

Discussion:

It was informed by Maj Gen Prof (Dr) Vibha Dutta, SM (Retd.) that two members of the external disciplinary committee formulated by Order dated 10/01/2025 had resigned hence the committee needs to be reconstituted. The President said that the members who had resigned can be replaced by some other external members and can be put up for approval by him.

Decision:

Confirmation of the Action Taken Report on the Minutes of Extraordinary Meeting of the Governing Body, AIIMS Gorakhpur held on 29.10.2024, it was decided that the Disciplinary committee would be reconstituted and their report would be considered in the upcoming meeting

Discussion:

Regarding Lien granted to Dr. Hari Shanker Joshi, Professor & Head, Department of Community & Family Medicine, Professor Ashoka Prasad was of the view that only conditional approval should be granted to him so that he may be called upon for various ongoing inquires. The President pointed out that it was already mentioned in his application that he may be called upon whenever there is a need for any inquiry, hence this automatically makes the lien conditional

Decision:

Ratification of Lien granted to Dr. Hari Shanker Joshi, Professor & Head, Department of Community & Family Medicine was unanimously approved

Discussion:

The President enquired about the rule position regarding the terms and conditions and duration of a lien to any faculty. The Executive Director and Dr. Ashoka Prasad informed that it was as per the AIIMS Act and is applicable for 2 years only and this can only be ratified by the President

Decision:

Ratification of Technical Resignation and Lien granted to Dr. Parul Singh, Assistant Professor, Department of Microbiology was approved unanimously

GB-06/09 Consideration on Writ Petition no. 396/2025 filed by Dr. Kumar Satish Ravi, Ex-Professor, Deptt. of Anatomy.

Discussion:

- 1. It was informed by the ED that the Hon'ble High Court of Allahabad has directed the Governing body of AIIMS Gorakhpur to submit their decision regarding relieving of Dr. Kumar Satish Ravi, Ex-Professor, Dept. of Anatomy, in a sealed envelope by 16th April 2025.
- 2. The ED made a point wise presentation of the vital details related to the matter. To refresh the memories of the GB members they were also shown a video recording of the previous 5th GB meeting held on 18/12/2024 where Dr. Satish Ravi has presented his case.
- 3. His presentation comprised of all documents related to his work experience and his credentials. As Dr Ashoka Prasad had recused himself from the previous GB meeting as per the directives of the Hon'ble NCSC, when the matter related to Dr. Kumar Satish Ravi was being discussed, the recording was shown to him also. The Hon'ble High Court order copy was the presented by the Member secretary before the committee members
- 4. The President observed that the members should now discuss on reviewing/amending or continuing the previous decision of relieving Dr Satish Ravi taken in the 4th IB held on 21st August, 2024.
- 5. There was a detailed discussion among the members regarding his appointment at AIIMS Rishikesh. To this Dr. Ashoka Prasad mentioned a formal communication by the then DDA AIIMS Rishikesh, where he mentioned that this matter was under inquiry and decision was pending at AIIMS Rishikesh. He also mentioned that Prof Ravi had not declared about this inquiry in the form submitted at AIIMS Gorakhpur. He also pointed out that the allegation by Dr. Ravi that he had not been given an opportunity to clarify his case was also wrong and that he was given ample opportunity first by him when he was inquiring the case on instructions from the President and then by the ED (Prof GK Pal). He also mentioned that facts regarding his pending inquiry were hidden from him by the then ED. Dr. Prasad mentioned that in his fact submission Dr Ravi has not countered the allegations in his power point presentation before the 5th GB.

- 6. Dr Tiwari said that we look into the possibility of repatriating him back to AIIMS Rishikesh on the post of Additional Professor. It was informed that it was not possible as he had applied by lateral entry and was technical resignation.
- 7. Prof Mathur observed that the same decision should be considered.
- 8. The Member Secretary had some observations that Dr. Kumar Satish Ravi has clearly declared all facts in his application form at AIIMS Rishikesh. But the members were of the view that misrepresentation at any point cannot absolve him in the future appointments.
- 9. The President observed that as the points put up in the discussions had already been deliberated upon multiple times and asked the members to put up any additional information beyond the previous discussions. As there was no further information put up, it was unanimously decided that the GB members would stick to their previous decision of relieving Dr Satish Ravi.

Decision:

Consideration on Writ Petition no. 396/2025 filed by Dr. Kumar Satish Ravi, Ex-Professor, Dept. of Anatomy, the members unanimously decided to stick to the previous decision of relieving of Dr. Satish Ravi. It was also decided that the same would be communicated to the Hon'ble High court of Allahabad in a sealed envelope.

GB-06/10: Any other agenda with the permission of Chair

Dr. Ashoka Prasad put up a proposal regarding engagement of Adjunct Faculty post to which the President observed that since it is a policy matter and hence can only be implemented after the approval from the Ministry.
