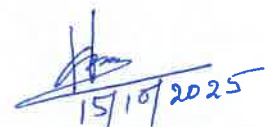

4. Subsequently, the Institute Body said that the copy of the decision is to be communicated to AIIMS, Rishikesh and ICMR, HQ, New Delhi about Dr. Surekha Kishore and Dr. Hari Shanker Joshi respectively in the form of a letter and the same should be shared with all the members of the Institute.

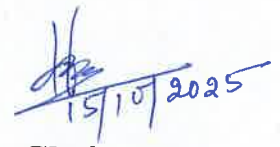
