### 1. About AIIMS Gorakhpur:

**1.1.** The All India Institute of Medical Sciences [AIIMS] was established to serve as a nucleus for nurturing excellence in all aspects of health and wellness programme throughout India.

**1.2** AIIMS are a group of autonomous public medical institutes that have been declared by an Act of Parliament 1956 as “Institute of National Importance”. All India Institute of Medical Sciences, Gorakhpur is one of the INI under Pradhan Mantri Swasthya Suraksha Yojna (PMSSY).

**1.3** As per Section 23 of the AIIMS Act: “Recognition of Medical, dental and nursing qualifications granted by the Institute [Notwithstanding anything contained in the Indian Medical Council Act, 1956 (102 of 1956), the medical degree or diplomas, as the case may be, granted by [every Institute] under this Act shall be recognized.

**1.4** Section 24 Grant of medical, dental or nursing degrees, diplomas, etc., by the Institute [Notwithstanding anything contained in any other law for the time being in force, [every Institute] shall have power to grant medical, dental or nursing degrees, diplomas and other academic distinctions and title under this Act.]

**1.5** Under the AIIMS, Act 23 & 24 as mentioned above gives the opportunity to the institute of develop and frame courses for the enhancement of the medical education of the country.

### 2 GOAL

Post- doctoral fellowship (PDF) and Post-doctoral certificate courses (PDCC) are offered for capacity building of postgraduates in specific areas.

### 3 AIMS

To enhance knowledge & skills of postgraduate students and faculty in special areas of their subject.

### 4 DETAILS OF THE COURSES

**7.3.2** Candidates failing to bring the above-mentioned original documents (7.3.1.1.1 to 7.3.1.1.7) will not be considered for final selection. Candidates are advised to visit AIIMS Gorakhpur website regularly for further updates.

**7.3.3** If a candidate fails to submit Original Documents of the requisite documents as above, his/her candidature will be cancelled and he/she will not be allowed to participate in subsequent stages of selection/admission process.

**8.1.1.8** There is no provision for re-checking/re-evaluation of the answer sheets and no query in this regard will be entertained.

**8.1.1.9** The decision of the Executive Director, of the Institute shall be final in the matter of selection of candidates for admission to PDF/PDCC Courses other Course and no appeal will be entertained in this regard.

**8.1.1.10** Selected candidates should be joining the course within the stipulated date mentioned in the offer letter. Failing which, the selection/admission shall stand cancelled.

**8.1.1.11** Selected candidates should submit their original documents at the time of joining.

**8.1.1.12** The selection of candidates in PDF/PDCC Courses will have to undergo for medical fitness.

Candidate will not be permitted to pay fee/join the course unless declared medically fit by the Medical Board duly constituted by the Institute. The decision of the Medical Board shall be final.

**8.1.1.13** Selected candidate for admission shall have to pay the prescribed fees within the stipulated period. Failing which, his/her admission shall be cancelled.

**8.1.1.14** Private practice in any form during the course is prohibited. The course is strictly full time.

**8.1.1.15** Prevailing rules are subject to change, in accordance with the decision taken by the Institute time to time.

### **9** Code of Conduct for PDF/PDCC Courses Students at AIIMS, Gorakhpur

#### **9.1** Maintenance of Discipline among students of the AIIMS:

**9.1.1** The following acts shall amount to gross indiscipline:

**9.1.1.1** Physical assault or threat to use physical force against any member of the teaching or non-teaching staff of any Department/Centre of AIIMS, Gorakhpur or any other persons within the premises/ Campus.

**9.1.1.2** Carrying or use or threat of use of any weapon.

**9.1.1.3** Violation of the status, dignity and honour of students belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes.

**9.1.1.4** Any practice, whether verbal or otherwise, derogatory to women.

**9.1.15** Any attempt to bribing or corruption in any manner

**9.1.16** Willful destruction of institutional property.

**9.1.17** Creating ill-will or intolerance on religious or communal grounds.

**9.1.18** Causing disruption in any manner of the functioning of AIIMS, Gorakhpur.

**9.1.19** Regarding ragging, the directive of Supreme Court will be followed strictly. It is as under: "As per direction of the Hon'ble Supreme Court of India, the Government has banned ragging completely in any form inside and outside of the campus and the Institute authorities are determined not to allow any form of the ragging. Whoever directly or indirectly commits, participates in abets or instigates ragging within or outside any educational Institution, shall be suspended, expelled or rusticated from the Institution. The punishment may also include cancellation of admission suspension from attending the classes, with holding of stipend payable or Cancellation of the result. The decision shall be taken by the Head of the Institution."

**9.1.2** Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate. The Executive Director, AIIMS, Gorakhpur may in exercise of his/her powers aforesaid order or direct that any student or students:

**9.1.21** Be expelled;

**9.1.22** Be, for a stated period: be not for a stated period, admitted to a course or courses of study in AIIMS Gorakhpur.

**9.1.23** Be fined with a sum of rupees that may be specified;

**9.1.24** Be debarred from taking any examination.

**9.1.25** Withhold the result of the student(s) concerned in the Examination(s) in which he/she or they have appeared be cancelled.

**9.1.26** Be prohibited for appearing or completing any examination for any unfair means like copying taking notes, mobiles or any other electronic gadgets inside the examination halls.

**9.1.27** At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Executive Director, AIIMS Gorakhpur and several authorities of the AIIMS, Gorakhpur who may be

Thereafter the action of cancellation of the registration of the concerned will be decided by Executive Director, AIIMS.
