ELIGIBILITY STATUS OF CANDIDATES AFTER COMPLETION OF DOCUMENT VERIFICATION FOR VARIOUS NON-FACULTY POST SELECTED THROUGH CRE-2025 AT AIIMS GORAKHPUR

1. In reference to Notice No.278/2025 dated: 11/07/2025 of CRE AIIMS New Delhi regarding recruitment of various non-faculty post on Direct Recruitment Basis on behalf of AIIMS Gorakhpur and in this connection, AIIMS Gorakhpur issued Notice No: AIIMS/GKP/RECT/CRE/2025-26/404 dated 04.12.2025, regarding verification of eligibility criteria & Original document for provisionally selected candidates of CRE-2025 for various non-faculty post on direct recruitment basis at AIIMS Gorakhpur. All the allotted candidates for AIIMS, Gorakhpur were called for document verification at AIIMS Gorakhpur 17.12.2025.
2. On the basis of documents submitted by the candidates in support of their eligibility and after examination of the documents, eligibility status of candidates has been prepared and placed as **ANNEXURE-A**.
3. The 'Provisionally eligible' candidates are mandatorily required to submit documents as mentioned against their Roll No. in support of their eligibility.
4. Candidates must note that their candidature is purely provisional and is subject to being declared 'Eligible' during verification of their original documents at the time of joining at AIIMS Gorakhpur. In case a candidate fails to submit any requisite documents related to recruitment process of CRE-2025, his/her candidature will be cancelled for the post forthwith. Further, if at any stage it is found that the selected candidate does not fulfil any of the eligibility criteria or if he/she concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection, his/her selection/appointment to the post will be cancelled forthwith at any stage without assigning any reason.
